









# PROMOTION OF SOCIAL ENTREPRENEURSHIP IN DISASTER RISK REDUCTION TO BUILD COMMUNITY RESILIENCE

# A REPORT ON THE PROJECT INCEPTION WORKSHOP

19-21 NOVEMBER 2019

#### **Executive Summary**

The project on "Promotion of Social Entrepreneurship in Disaster Risk Reduction to Build Community Resilience" commenced on 1 September 2019, funded by the International Development Research Centre (IDRC) for a duration of three years. The general objective of the Project is to foster long-term community climate resilience in Malaysia and Cambodia by

empowering young female social entrepreneurs to develop their own disaster resilience plans. Led by Universiti Kebangsaan Malaysia's Southeast Asia Disaster Prevention Research Initiative (SEADPRI-UKM), key partners include the Royal University of Phnom Penh (RUPP), Geological Society of Malaysia (GSM) and Malaysian DRR Service Organization (MDRRSO).

The Inception Workshop of the Project was held on 19-21 November 2019, in conjunction with the visit of the IDRC Programme Manager, Dr. Mélanie Robertson. The Inception Workshop comprised two meetings involving key partners as well as a total of six courtesy calls; to the Disaster Management Unit of Selangor State, four federal agencies i.e. National Disaster Management Agency (NADMA), Ministry of Energy, Science, Technology, Environment and Climate



Change (MESTECC), Ministry of Economic Affairs (MEA) and Academy of Sciences Malaysia (ASM), as well as the Canadian High Commission.

Key follow-up actions from the Inception Workshop are:

- Formalize the institutional arrangement between SEADPRI-UKM and the State of Selangor Darul Ehsan to implement the project;
- Formalize arrangements to involve NADMA, MESTECC, MEA and the ASM as members of the Project Steering Committee to monitor and evaluate progress;
- Expand linkages with the Ministry of Women and Welfare, Ministry of Youth and relevant parties to involve more women and youth as well as provide policy guidance;
- Implement the Open Access Policy of IDRC and ensure coherence between the digital platforms of ASM, SSCC and other parties (i.e. MetMsia, JPS, etc.) including the regional platform of the Digital Belt and Road Working Group on DRR, where SEADPRI-UKM serves as the institutional liaison for ASEAN, drawing on the experience of Dr. Nyda in Cambodia.

The Project will be managed in line with the agreement that was signed between UKM and IDRC. Aspects of critical importance are:

- The project will submit a Financial Report and Progress Report annually to the Program Manager. The first report is due in early September 2020 and the Project Manager needs to keep track and ensure that this requirement is met;
- The Progress Report should refer to all aspects mentioned in the Project Agreement and the reporting should be done according to the stated objectives;
- Financial reporting will include compilation of a copy of receipts for every item of expenditure and the interest accrued (if any) will be recorded accordingly;

All activities and achievements of the project should be reported immediately and a quarterly update is required, covering aspects of publications, activities undertaken, research findings including literature review, outcomes, recommendations, etc., which can be shared in an Annex or by providing a website link.

#### Agenda

The Chair extended her warm welcome to the members of the meeting and introduced the group to Dr. Mélanie. This was followed by a presentation on the background of the project funded by the IDRC. The main objective of the project is to foster long-term community resilience in Malaysia and Cambodia through the empowerment of young women's social entrepreneurs in developing disaster resilience plans. The project has raised RM 1.5 million to run over three years in four pilot areas (Kuala Selangor, Shah Alam and Ampang Jaya in Selangor as well as Kpg Speu in Cambodia).

Points of discussions and follow-up actions are:

- 1. Monitoring & Evaluation (M&E): The meeting agreed that project evaluation will be based on the project objectives (rather than Work Packages), which would direct the way progress reports are structured.
- **2.** Log Frame: Project Log Frame as provided in the proposal has been discussed and agreed upon.
- **3. UKM Research Ethics:** Research conducted in the project involving human subjects will abide by research ethics as outlined by UKM. Where the standards differ, the Canadian research ethics will be followed.
- **4. Open Access Policy:** IDRC will share their present Open Access Policy for reference and emulation.
- **5. Expectations from IDRC:** Any events, publications, media coverage and output from the project must be credited to IDRC and reported to the Program Manager.
- **6. Budget:** The prepared budget needs to be followed and spent accordingly (avoid over-spending or under-spending).

#### 7. Reporting to IDRC:

- a) Research progress reporting will be made annually; project achievements can be updated regularly pertaining to events and activities, publications, media coverage, etc.
- b) <u>Financial reporting</u> will be made annually; issues/questions need to be communicated in advance before the report is due.

#### 8. Other Business:

- A framework for a Kick-off Workshop in January 2020 was developed for discussion with federal and state agencies during the courtesy calls.
- Briefing to the Chief Minister of Selangor: The High Commission of Canada will be invited to the Meeting with Selangor Chief Minister as well as for the Project Launch in January 2020.

The Chair extended his warm welcome to the guests and introduced the group to the SSCC and their operational team. This was followed by discussion session as summarised below: **Presentation by Mr. Ahmad Fairuz, Head of the SMART Selangor Command Center (SSCC):** A briefing from SSCC on the commitment of the State Government towards the people. This included a briefing on their facilities, assets, their operational conducts, technical needs and struggles with regards to hazards monitoring, early warning, emergency response and solutions for short and long-term risks.

**Presentation by Prof. Dr. Joy Jacqueline Pereira, SEADPRI-UKM (Project Leader):** A presentation on the background of the IDRC funded project and how the project could help the State improve their efforts for DRR.

**Presentation by Ms. Eriko Motoyama, IRIDeS, Tohoku University:** A presentation on the background and activities of the ongoing project for Selangor funded by JICA, Japan. The project is titled "Strengthening the Disaster Risk Reduction Capacity to Improve the Safety and Security of Communities by Understanding Disaster Risk (SeDAR)".

#### **Points of Discussion:**

- The IDRC project can leverage on the findings and achievements made in the JICA project mainly to improve awareness of the communities. The IDRC project can facilitate the same communities in mobilizing the next step, which is assessing the readiness for social entrepreneurship for DRR to build disaster resilience in the communities.
- The Selangor State Secretary's Disaster Management Unit is willing to cooperate with the IDRC project and open the door to counterparts to come out with solutions for DRR and they are willing to share their data inventory for the work.

#### Follow up Actions:

- SEADPRI-UKM will send an official invitation letter to the State Secretary and get the endorsement for the Disaster Management Unit to cooperate on the project.



 Once the letter is received, a meeting will be scheduled in December 2019 to brief the Chief Minister regarding the project. The Canadian High Commissioner or her representative will be invited for the meeting.
